ASSESSOR/ GRIEVANCE DAY

Grievance Day was held on May 25, 2022. 15 parcels went through the Board of Assessment review. BAR reduced approximately ½ and approximately ¼ stayed the same and ¼ increased. On July 1,2022, residents can file for SCAR if they did not agree with the BAR adjustments. Assessor, Heather Garner will represent the Town of Ledyard at the SCAR hearing. Assessor, Garner will also apply for funding through the state for Small Claims Assessment Review; SCAR. This will be \$5/per parcel of funding if the town qualifies for the aid. 2016 was the last re-evaluation that was done for the Town of Ledyard.
