HISTORIAN

The town historian borrowed a traveling exhibit about the Erie Canal that celebrates its bicentennial (1825-2025) which is on display next to the flag in new meeting room at town hall for the next month. Shirley will add an exhibit board about Ledyard's connection to the Erie Canal.

The proposal had two payment options: (1) town pays ~\$200,000 and receives 100% of revenues or (2) town pays \$100,000, CSEV pays \$100,000 and revenues are split 50-50%. Discussion followed.
