PRIVILEGE FROM THE FLOOR

Legislature for District 7: Springport, Ledyard, Scipio, Robert Shea attended the meeting. Shea spoke to the board regarding the proposal to reduce the size of the county Legislature from 15 to 11 members and redraw district maps. This will be up to the voters at the upcoming elections. County roads was mentioned by Supervisor Jordan who stated, that the town should take care of the town and county roads due to it being so rural. Legislature Shea also stated that he is working on the internet. Currently there are approx. 20 miles of "gaps" (344 customers) where internet service still is not available.

Resident, Ron Harrison also addressed the board and expressed his frustrations regarding his assessment. Supervisor, Jordan stated that he needed to present this to the Board of Assessment Review and if he was not satisfied with their decision, he could then take it to the county (SCAR).
