Removal of ZONING LAW Section Article 2, Section 2, Paragraph c.

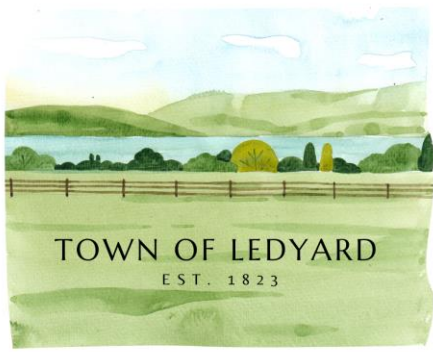
B. "Definition of Properties Governed:

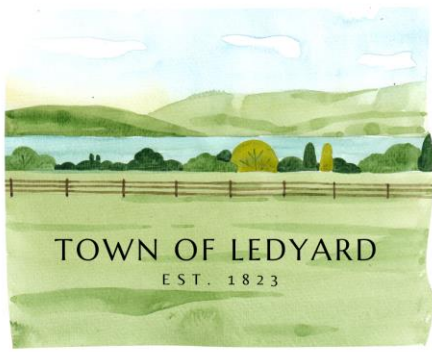

CAYUGA COUNTY WATER AND SEWER

Carl Rindfleisch spoke with Supervisor Jordan and he was going to attend April's board meeting. City of Auburn takes their water out of Owasco Lake. Aurora gets theirs from Wells who draws from Cayuga Lake. At this time there is no discussion about doing anything more at this time. Auburn believes they can support the new milk plant from Owasco. Sewer lines were discussed in the past and at this time, there has been no further discussion. Approx cost would be \$62k for each resident with approx. 475 homes. A lot of discussion was held.

Street Light Conversion in Levanna is currently \$60 month/light. NYSEG would like to convert to LED.

Town of Genoa will not be hosting the swim program this year. Students will have to use the Wells College Program.

HIGHWAY

Supervisor Jordan mentioned the passes.

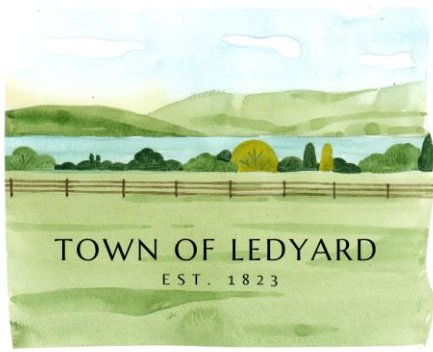
