PRIVILEGE FROM THE FLOOR

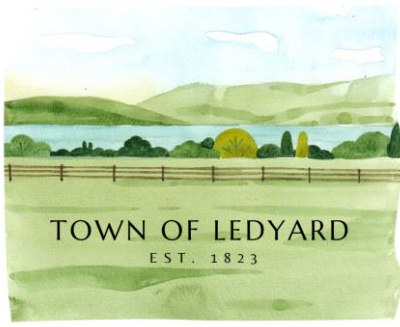
Terry Denman from the NY Citizens Audit Committee spoke. Denman does not support any candidate or political party. When covid began a group of New Yorkers set forth to determine if NY elections were fair and honest. A foil request from the committee brought back over 5 million apparent registrations violation. Over 1 million duplicated registrations. It is believed that our votes (despite party) are being diluted.

Foil Findings include.

- 2,340 Double name registrants
- 51,150 Blank name registrants
- 19,712 age discrepant registrants
- 338k more votes were cast than voters

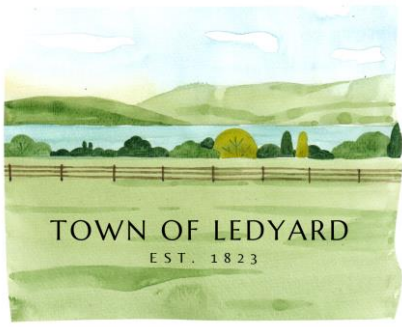

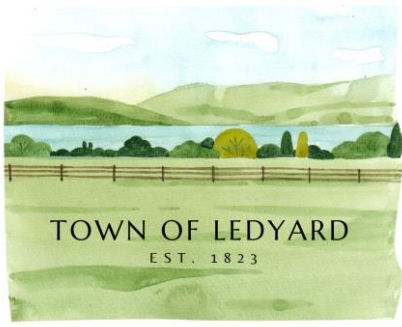
HIGHWAY
