HIGHWAY

- New truck won't be delivered until the second part of next year. Warranty won't start until delivered.
- Truck #5 – had to be sent out to get repairs done which cost ~\$10,000. The bill has been vouchered.
- Presented 3 quotes – Ford, International and Chevrolet for 1 ton, dump truck, plus quote for the accessories. Discussion followed concerning the need and how to justify the cost. Tabled until next meeting. Jason will talk with highway superintendents from Venice, Scipio and Genoa who have similar trucks

TextMyGov presentation via Zoom

TextMyGov was developed to open lines of communication with local government using text messages via smartphones instead of visiting town website. A proposal was sent to Town at a cost of \$4500 for the first year and \$3000 annual for the next 2 years for the 3-year agreement. Discussion followed with company and included setup, notifying residents of issues or updates or residents notifying town of issues, what happened if went over or under total text messages per year. Town will have sheets at town hall and transfer station for

residents to sign if they would be interested in receiving text messages from town. A TextMyGov link will also be on website.

HISTORIAN

- Borrowed two specimens from Paleontological Research Institution for our display case to accompany the 1819 edition of *Travels Through the Western Country in the Summer of 1917* by David Thomas.
- The Aurora Ledyard Historical Society is very grateful (and excited) about your offer of a place to bury the Community Time Capsule.
- Purchased a 1937 obsolete bank note for the Town of Ledyard’s Historical Archive: One Shilling, issued at Levanna, on July 29, 1837. Notice the modern spelling, not Levana, was in use by then. Was passed around.
