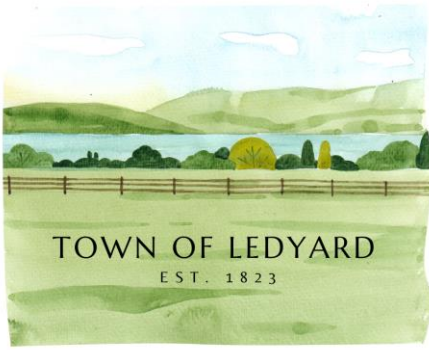

The generator quote is getting redone. The board has already approved the purchase of the generator.

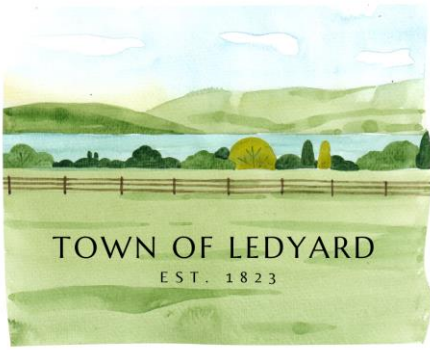
